DRB-HICOM REVENUE IN Q1 FY2018/19 AT RM2.65b

SHAH ALAM, August 28, 2018 : DRB-HICOM Berhad's (DRB-HICOM, the Group) first quarter results for the quarter ended 30 June 2018 has been announced, with revenue coming in at RM2.65b, leading to a pre-tax loss of RM94.4m for the period.

OVERALL REVIEW

Revenue for the Automotive Sector came in at RM1.40b, with national carmaker PROTON delivering 6,173 units in June 2018. As with the rest of the industry, all marques under the Group recorded markedly increased sales in June, and have continued to do so in the following months.

DRB-HICOM's Services Sector revenue was recorded at RM1.11b for the period under review, while the Property sector's revenue for the three month period amounted to RM142.80m.

PROSPECTS FOR THE REST OF THE YEAR

Malaysia's economy is expected to remain favourable with domestic private consumption continue to drive economic growth.

The Group's Automotive sector is expected to gain momentum, with the impending PROTON SUV to be launched by the end of 2018. New product launches from other marques as well as promotional activities will act as catalyst to drive sales volume further.

To better focus on capital management and flexibility to pursue growth strategies, the Group continues to find ways to unlock value from its assets. DRB-HICOM's recent announcement of the sale of waste management subsidiary Alam Flora Sdn Bhd, and

the earlier proposed rationalisation of non-industrial property assets is in-line with this initiative.

Amidst a business landscape that continues to be challenging, the Group will remain focused on driving operational efficiencies while maintaining capital discipline and operational excellence across all its businesses and subsidiaries to steer the entities forward.
