ADMINISTRATIVE GUIDE FOR SHAREHOLDERS

A. HOW TO PARTICIPATE IN THE ANNUAL GENERAL MEETING (“AGM”) REMOTELY

1. Please note that the Remote Participation and Electronic Voting (“RPEV”) facilities is available to:
 - (i) Individual members;
 - (ii) Corporate shareholders;
 - (iii) Authorised nominees; and
 - (iv) Exempt authorised nominees.
2. At the on-line meeting, you will be able to submit questions to the Board via the meeting platform at <https://meeting.boardroomlimited.my>, and cast your votes for the resolutions in real time.

Shareholders may submit questions on the AGM resolutions and Annual Report 2021 in advance commencing from 29 April 2022 and in any event, no later than 10.00 a.m., Monday, 20 June 2022 via Boardroom’s website at <https://investor.boardroomlimited.com>. Using the same user ID and password provided in Step 2 below, select “SUBMIT QUESTION” and pose your questions (“Pre-AGM Meeting Questions”).

3. To participate in the AGM, you will need a login ID and a password. The following steps will enable you to secure the login ID and password.

STEP 1

Register On-line with Boardroom Smart Investor Portal (“BSIP”) (For first time registration only. If you have an existing BSIP ID, go to Step 2)

[Note: If you have already signed up with BSIP previously, you are not required to register again; you may proceed to Step 2 (submit request for Remote Participation user ID and password)]

- a. Access website <https://investor.boardroomlimited.com>
- b. Click <<Register>> to sign up as a user
- c. Complete registration and upload softcopy of MyKAD (front and back) or passport in JPEG or PNG format
- d. You will receive an e-mail from BSIP Online for e-mail address verification. Click on “Verify E-mail Address” from the e-mail received to proceed with the registration.
- e. Once your e-mail address is verified, you will be re-directed to BSIP Online for verification of mobile number. Click on “Request OTP Code” and an OTP code will be sent to the registered mobile number. You will need to enter the OTP Code and click “Enter” to complete the process.
- f. Once your mobile number is verified, registration of your new BSIP account will be pending for final verification
- g. An e-mail will be sent to you within one (1) business day informing on the approval of your BSIP account. You can login at <https://investor.boardroomlimited.com/> with the e-mail address and password that you provided during registration to proceed with the next step.

STEP 2

Submit Request for Remote Participation User ID and Password (For shareholders with an existing BSIP ID)

Registration for remote access will **commence on 29 April 2022**. Please note that the **deadline to submit your request is at 10:00am on 20 June 2022** (48 hours before the AGM).

- i. Login to <https://investor.boardroomlimited.com> using the user ID and password you created
- ii. Select and click on “Corporate Meeting”
- iii. Go to “DRB-HICOM Berhad 32nd Annual General Meeting” and click Enter
- iv. Go to “VIRTUAL” and click on Register for RPEV
- v. Read and agree to the Terms & Conditions
- vi. Enter your CDS account number and click Submit to complete your request.

Corporate Shareholders

- i. Write in to bsr.helpdesk@boardroomlimited.com with the name of Member, CDS Account Number accompanied with the Certificate of Appointment of Corporate Representative or Form of Proxy to submit the request
- ii. Please provide a copy of the Proxy Holder’s MyKad (front and back) or passport in JPEG or PNG format as well as his/her e-mail address

Authorised Nominees and Exempt Authorised Nominees

- i. Write in to bsr.helpdesk@boardroomlimited.com with the name of Member, CDS Account Number accompanied with the Form of Proxy to submit the request
- ii. Please provide a copy of the Proxy Holder’s MyKad (front and back) or passport in JPEG or PNG format as well as his/her e-mail address

Once you have completed the steps above:

- a. You will receive a notification from Boardroom that your request has been received and is being verified
- b. The system will verify your registration against the AGM’s Record of Depositories, and you will receive an e-mail from Boardroom either approving or rejecting your registration for remote participation
- c. If approved, you will also receive your remote access user ID and password along with the e-mail from Boardroom

You are now set to be a participant at the AGM, and you can log in on the AGM day as explained below.

Please note that the deadline to submit your request is at 10:00am on 20 June 2022 (48 hours before the AGM).

STEP 3

Logging into the Virtual Meeting Portal on AGM Day

[Please note that the quality of the connectivity to Virtual Meeting Portal for live webcast as well as for remote on-line voting is dependent on the bandwidth and the stability of the internet connection available at the location of the remote users]

- a. The virtual meeting portal will be open for logging in at 9:00am on 22 June 2022 (one hour before the commencement of AGM at 10:00am)
- b. Follow the steps given to you in the e-mail; use your user ID and password to login to the virtual meeting portal (refer to Step 2 above)
- c. The steps will also guide you on how to view the live webcast, ask questions and vote
- d. Please ensure your devices are in good working condition, and is fully-charged or connected to a power outlet; the use of earphones is recommended for better audio clarity
- e. Upon closing of the AGM by the Chairman, the live web cast will end and the messaging window will be disabled

You can leave or log out from the portal/exit the meeting at any time.

B. HOW TO VOTE

1. The voting will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

DRB-HICOM has appointed Boardroom Share Registrars Sdn. Bhd. as Poll Administrators to conduct the poll by way of electronic voting (e-voting), and Sky Corporate Services Sdn. Bhd. as Scrutineers to verify the poll results.

2. For the purposes of this AGM, e-voting will be carried out via the following voting devices:
 - a. personal smart mobile phones;
 - b. tablets; or
 - c. laptops or personal computers (PC)
3. There are two methods for members and proxies to vote:
 - i. use a QR Scanner Code given in the e-mail sent to you at registration, **OR**
 - ii. access the website URL <https://meeting.boardroomlimited.my>
4. The polling will only commence after the Chairman announces opening of the polls, and will remain open until such time when the Chairman announces the closure of the poll.
5. Once a poll is closed, the Scrutineers will verify the poll result reports and they will announce the results thereafter. The Chairman will declare whether the resolutions put to vote were successfully carried or otherwise.

C. HOW TO LODGE THE AGM PROXY FORM

1. If you are unable to join the broadcast of the AGM on 22 June 2022 and wish to appoint the Chairman of the Meeting as your proxy to vote on your behalf, please deposit your proxy form electronically via “Boardroom Smart Investor Portal” at <https://investor.boardroomlimited.com>.

The lodgement must be done no later than 48 hours before the AGM i.e. latest by Monday, 20 June 2022 at 10.00 a.m.

To lodge the form electronically, kindly read and follow the guidelines which are detailed below:

STEP 1

Register On-line with Boardroom Smart Investor Portal (for first time registration only)

[Note: If you have already signed up with BSIP, you are not required to register again; you may proceed to Step 2 below for e-Proxy Lodgement]

STEP 2 – e-Proxy Lodgement

- a. Access Boardroom’s website at <https://investor.boardroomlimited.com>
- b. Login with your user ID (i.e. e-mail address) and password
- c. Go to “Corporate Meeting” and browse the Meeting List for “DRB-HICOM Berhad 32nd Annual General Meeting” Then, go to “PROXY” and click on Submit e-Proxy Form
- d. Read the Terms & Conditions and confirm the Declaration
- e. Enter the CDS account number and indicate the number of securities for your proxy/ies to vote on your behalf
- f. Appoint your proxy/ies or the Chairman of the Meeting and enter the required particulars for your proxy/ies
- g. Indicate your voting instructions – FOR, AGAINST or ABSTAIN, otherwise your proxy will decide your vote
- h. Review & confirm your proxy/ies appointment, and click “SUBMIT”
- i. Download or print the e-Proxy form acknowledgement

This too must be lodged not later than 48 hours before the AGM i.e. latest by Monday, 20 June 2022 at 10.00 a.m.

Revocation of Proxy

If you have submitted your Form(s) of Proxy and subsequently decide to appoint another person or wish to participate in our electronic AGM by yourself, please write in to bsr.helpdesk@boardroomlimited.com to revoke the earlier appointed proxy/ies. This must be done at least 48 hours before the meeting.
